IHM / ICM Associates Program in Mexico

Our IHM community, like other congregations, has been in search of more vocations and other ways of working in ministry by relating to other people.

Today we understand the concept of vocations in a more diverse way. We value the opportunity to connect with people who identify with our spirituality, charism, work and community life.

In Ciudad Juárez, Chih, Mexico, since the beginning of our mission, we have promoted this program among lay people who feel the desire to know us better and participate more closely in our ministries.



Since 1990, we began the experience of the program with a lay woman associated in prayer with us, Teresa Delgado. We are sure that she continues to pray for our congregation from the presence of God.

In 2015, a married couple: Valentín "Pancho" Alanís and Hildelisa Ávila worked in the Ecclesial Base Communities and continued together for some years in the Paso del Norte Human Rights Center. For two years, they met every two weeks with Sister Carmen Armenta. They made their commitment in their Chapel three years ago and renewed this year at their home with their family and the IHM / ICM community.

Hildelisa and Valentín have lived their mission for years with a commitment to justice and peace for the families who have been victims of enforced disappearance. They have done pastoral work with vulnerable people in parish communities. We consider that their close presence as associates has helped motivate us to continue to deepen our mission as an IHM / ICM community in Mexico.

"... we commit ourselves to mutuality in ministry, desiring that our love, reverence, and support of one another be reflected in the way we affirm, encourage, and work with our co-ministers and with each of the persons among whom we serve" IHM Constitutions Chapter 2 Art. 17

The community of Sta. Elena has been generous in embracing this association proposal from the Mexican culture. Now we are accompanying five more people as possible associates in Juárez, Mexico. There are two married couples: Ramiro and Sonia, Maria Eugenia and Ernesto and a lay person Norma, who have participated for a long time in church and social justice. The IHM / ICM sisters: Carmen, Antonia and Maureen are sharing with them every Monday.

From what they have experienced and known about our congregation in these years of working closely with us in the Chapel of Santa Elena de la Cruz, the formation experience as associates has been profound for them and for us. We believe that the IHM-ICM Associates Program is of great help to people. Those who are in search of a deeper spiritual aspect in their life want to put their gifts and talents into practice, not only within ecclesial religious activities, but also in our society and in the diverse environments (school, work, community, political, social, etc.) in which each one of them participate.

We believe that this partnership can overcome cultural and social limits to enrich lives and our IHM / ICM mission also wherever we are serving as a community.

We hear in our Constitutions a call to respond to human needs and we live our call by participating with those who want to work for the Kingdom and continue the redemptive mission of Jesus. We believe the Associates Program helps us to respond to the synodal call that Pope Francis proposes for us to carry out in our pastoral work.

Sue Rakoczy: Bonum Commune

Each year at graduation at St. Augustine College, we present a *Bonum Commune* award to some person who has contributed significantly to the 'bonum' of the 'commune', the good of the community, be it the country, the church, academic life, or the institute itself. For the past four years, I have written the citations for the award, which included one for Albert Nolan OP and the local Archbishop Buti Thlaghale. I would like by way of this *Overseas Update* to present Sue Rakoczy a *Bonum Commune* award in testimony for her incredible contribution to the academy, the church, and the larger South African Society. Such a citation is usually 3-4 pages in length, but here it will be shorter.



Sue entered the IHM community in 1967 after completing her BA at Marygrove College, and in the heady — and tumultuous — years just after the conclusion of the Second Vatican Council. She would study at Fordham and then earn a doctorate at Catholic University of America. Upon completion of her studies she worked for a short time in the diocese of Kansas City-St. Joseph, Missouri as a staff member of the Center for Pastoral Life and Ministry working with laity.

Shortly, the possibility of working in Africa was moot. As Sue recalls, the world was wide open, and the church was 'new and fresh' in Africa. With the blessing of the

IHM community, off she went in 1982 to spend six fruitful years in Ghana. There were obstacles, however. Her original invitation was to teach at a seminary, but that was withdrawn. Instead she served at a retreat center, making lifelong friends and 'honing' her spirituality skills.

In 1989, at the invitation of Mary Jo Maher, Sue came to Howick in South Africa and began to teach at St. Joseph's Theological Institute. Here, her academic gifts flourished. She taught in the undergrad program and soon was also teaching postgrad students at the neighbouring University of Natal (now KwaZulu-Natal). The unique Cluster arrangement of the Institute with neighbouring theological faculties gave her a wide spectrum of ecumenical contacts and broader teaching possibilities. Sue was involved in establishing the publication arm of this Cluster, and helped edit *Grace & Truth*, the theological journal of the Institute. When she retired as Book Review editor after many years, one of her colleagues was aghast: 'Oh no! Who will do all this work now? We will need four people to replace her.'

At St. Joseph's Sue taught systematic theology and spirituality, establishing a course in Women Doing Theology (using her own text as the basis), and offering a course in Spiritual Accompaniment which drew students from beyond the Institute. She also coordinated the postgraduate programs in Catholic Theology and Christian Spirituality through the University, supervising students at every level. A list of her publications and presentations extends to three full pages and deals with a variety of topics. These topics include Ecofeminism, HIV-AIDS, spiritual direction, and social justice, and

figures such as Dorothy Day, Dorothy Stang, Florence Nightingale, Wangari Maathi and Thomas Merton.

Her biannual production of this *Overseas Update* was established and maintained by Sue. The update draws from often reluctant writers to produce a written record of the engagement of all who have been involved in the overseas ministry of the IHM congregation.

One needs not mention her substantial involvement in the ongoing spirituality project of the IHM's which is known to us all.

Sue's 'Bonum' to our 'Commune', both the IHM community here and elsewhere, to the Church in South Africa, to the academic life of the country would certainly merit her such an award now as she brings to a successful conclusion 39 years of meaningful ministry on the continent and 54 years of life in the IHM community. Thank you, Sue. *Siyabonga kakhulu*!

South Africa: The Struggle Continues

Bad news seems to be piling up in South Africa – not to mention disturbing news all over the world. A fourth wave of Covid-19 is expected here in November; proper HIV/AIDS medication has been mostly not available for several months. The latest job results are grim, at 44% unemployment, said to be the worst globally. In July there was serious arson and looting in KwaZulu-Natal and Johannesburg areas. There were



drive-by shootings of ANC municipal election voters. Former President Jacob Zuma was sentenced to jail time for contempt of court while facing more counts of corruption. It seems like winter in South Africa. It takes faith to believe that things are actually improving.

Meanwhile the three of us IHMs in South Africa are continuing our various ministries of education from preschool to higher degrees, as well as outreach to the most vulnerable among us. Donors in the U.S. have made it possible to give daily sandwiches to children who are not receiving food at school. Children in our preschool also receive a hot meal in addition to educational preparation for first grade. Seminarians and lay people are given opportunities to study theology and other life skills. A support group for HIV-AIDS continues to assist people to connect with clinics and hospitals and to provide transport to receive two Pfizer shots. With no expectation

of quick outcomes, we continue to offer education and healing and to learn from the country where we will always be guests.

Some days it seems like things are the same as the day each of us arrived in South Africa. On other days, we trust in the Spirit who is transforming the whole world one person and one community at a time. It is a privilege to walk with people of other cultures and to face the challenges that life brings us both here and in the U.S., knowing that Jesus did not turn his face from suffering and by his commitment he overcame everything, including death. We look toward to spring in South Africa.



A Time Like No Other: COVID 19 in Women's Voices

I have been a member of the South African Circle of Concerned African Women Theologians since the mid1990s. The Circle was founded in 1989 by Mercy Oduyoye of Ghana to encourage women to meet and support one another to write and publish their theological reflections. Circles meet in many African countries and have been very productive.

In March 2020 when the COVID-19 lockdown began in South Africa, a small group of Circle members including myself, organized ourselves as a Friday afternoon sharing group on Zoom. One Friday in April we decided to work towards a book on women's experiences of the pandemic.

Four of us — Nontando Hadebe, Daniela Gennrich, Nobesuthu Tom and myself — began



to work as the editorial team and put out a call for submissions. We have a wide network and to our delight the contributions began to fill our mailboxes. We received heart-rending reflections of death and stories of resilience. There were poems, prayer services and artwork. Women wrote honestly of how very difficult the pandemic has been and continues to be for them, especially when there was a violent man living in the house. Gender based violence (GBV) increased so dramatically that at one of his "family meetings" on Sunday evenings President Cyril Ramaphosa named GBV as "a second pandemic". The youngest contributor who was ten years old sent her artwork.

I did much of the copy editing and I was moved by the women's reflections as I read them. The other members of the team helped find funding through various national and international contacts. A local artist donated her beautiful paintings for the cover and as divider pages.

Slowly, the book took shape in six sections: Tribute and Trauma, Lament, Ministry Challenges, Trials and Faith, Ministry Challenges and Hoping. We deliberately titled the final section "hoping"—as a verb of action, not a noun of possession.

August is National Women's Month in South Africa and so we had our launch via Zoom on the 9th, National Women's Day, a public holiday. Over 130 people attended. The print run was 370 copies and they sold rapidly. "We Will Speak Out SA", a faith-based organization working to end gender based and sexual violence (www.wwsosa.org.za), has provided a link to the pdf of the book.

In September, a launch sponsored by Future Church drew over 200 people. People clamoured for the book—but had to read it online. We are hoping for a US publisher and are also raising money for a second print run.

It is a truly significant Circle publication and I am very glad to have been part of the team which brought it to birth.
